Each year Everett PTSA Council recognizes volunteers and educators who have given outstanding, continued and dedicated service to our children. These deserving recipients go "above and beyond", and their efforts reach beyond the usual school boundaries. This is your opportunity to participate in the selection of our award recipients by nominating candidates for consideration by our award committee. Nominations can come from PTAs, parents, staff members, students, or community members.

The Everett PTSA Council Awards are presented at the annual council banquet in May. Nominations are accepted for all awards, though each award may not be presented annually. The awards committee is appointed by the President, and typically consists of past recipients. For all of the WSPTA Awards, a contribution in the name of the recipient is made by the Everett PTSA Council to the Washington State PTA Scholarship Program. From these contributions, WSPTA is able to provide grants to freshman students entering post-secondary education.

GOLDEN ACORN AWARD

The Golden Acorn Award is presented to a volunteer in recognition of his/her dedication and service to children and youth.

OUTSTANDING EDUCATOR AWARD

The Outstanding Educator Award recognizes individuals who have provided outstanding educational opportunities for children and youth that are beyond the normal scope of their jobs at their own schools. These educators make learning fun, beneficial, and challenging district-wide.

OUTSTANDING ADVOCATE AWARD

The Outstanding Advocate Award recognizes and honors individuals for their continued and dedicated service to ALL children and a demonstrated commitment to helping create strong policies relating to the health, welfare, safety, and education of children and youth.

OUTSTANDING STUDENT ADVOCATE AWARD

The Outstanding Student Advocate Award recognizes students who have made significant contributions through leadership and service in their schools and community.

HONORARY LIFE MEMBERSHIP AWARD

The purpose of the Honorary Life Membership is to recognize an individual who has contributed significantly to a PTA at the local unit, council, or state level. This special award can be given by a PTA unit, council, or region.

OUTSTANDING SERVICE AWARD

The Outstanding Service Award is presented to a volunteer who works for children and youth beyond the bounds of a job, PTA, or a specific school community. This honor goes to a person who has shown concern for all children and who has volunteered his/her time to help them achieve their potential. This special award can be presented to an individual who may have already been honored, but who continues to give extraordinary volunteer service to children. It is the highest award a volunteer may receive.

SPIRIT OF THE COMMUNITY AWARD (Everett PTSA Council award)

The award is specific to the Everett PTSA Council and is presented to a business, group, or individual whose work impacts children in the Everett community.
